Unlimited use of the golfing privileges and use of the locker room, bag storage, and clubhouse for individual, spouse, or dependent children.
(Must be paid by January 31, 2025 to receive the annual dues discount)

FOUR-DAY GOLF MEMBERSHIP: (Must be paid by January 31, 2025 to receive the annual dues discount)

Golf Four-Day Single Dues: \$1,500.00 \$172.00 per month x 10 months

ASSOCIATE GOLF MEMBERSHIPS:

An Associate discount is provided to persons ages 21 to 29. Associate memberships are categorized by a golf membership. Members ages 21 to 29 are not entitled to voting privileges (see By-Laws). (Must be paid by January 31, 2025 to receive the annual dues discount)

High School: 15-18	Dues: \$400.00

NON-RESIDENT GOLF MEMBERSHIP:

Any person desiring such membership must reside in a permanent residence beyond forty (40) mile radius of the SVCC and may not reside within the radius for a period exceeding thirty (30) days per year or maintain a second residence within the radius for personal use during the golf season (Section 7-B of By-Laws). (Must be paid by January 31, 2025 to receive the annual dues discount)

Golf Non-Resident Dues: \$1,265.00 \$141.00 per month x 10 months

SOCIAL MEMBERSHIPS & POOL MEMBERSHIPS:

Unlimited use of the pool and pool facilities for individual, spouse, or dependent children. Social Members are permitted to play golf four times per year while paying reduced greens fees. Participation in club tournaments is not permitted unless designated and advertised to Membership by the Golf Professional. The Club will provide 10 guest passes (for free) and additional passes may be purchased for \$5.00 per guest per day. (Dues must be paid by May 31, 2025)
